**WHEREAS** it is enacted by Section 3 of the Land Acquisition Act Chapter 241 that if the Governor General considers that any land should be acquired for a public purpose, he may cause a declaration to that effect to be made:

**AND WHEREAS** it is considered by the Governor-General, that the under mentioned parcels of land should be acquired for a public purpose, to wit, Public Sector Development.

**NOW IT IS HEREBY DECLARED** by His Excellency, the Governor-General, acting in accordance with the advice of the Cabinet of Saint Vincent and the Grenadines, that upon the Second Publication of this Declaration in the Gazette, all that portion of land situated at Mt. Pleasant, in the Parish of St. George in the State of St. Vincent and the Grenadines belonging to Noel Baynes and et. al. measuring 600 and 3060 sq. ft. together with all ways water and watercourses rights, lights, liberties, privileges, paths, easements and all other appurtenances thereon shall vest absolutely in the Crown.

**AS IT IS HEREBY FURTHERED DECLARED AND NOTIFIED** that a drwaing bearing registration number G759, lot #17 and adjacent outlining the above-mentioned area is at the Land and Surveys Department and can be inspected at all reasonable hours at the said Department.

The Government of St. Vincent and the Grenadines (GOSVG) has received financing from the Caribbean Development Bank (CDB) in an amount equivalent to USD 12, 317 million towards the cost of Technical and Vocational Educational Training (TVET) Development Project and intends to apply a portion of the proceeds of this financing to eligible payments under a contract for which this invitation is issued.

Payments by CDB will be made only at the request of GOSVG and upon approval by CDB, and will be subject in all respects to the terms and conditions of the Financing Agreement. The Financing Agreement prohibits withdrawal from the financing account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of CDB, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than GOSVG shall derive any rights from the Financing Agreement or have any claim to the proceeds of the Financing.

Ministry of Education (MOE), the Executing Agency, now wishes to procure consultancy services for **Project Management Service**.

The objective of the consultancy is to assist the Project Coordinator in setting up and strengthening of a project management system to enhance the implementation of the TVET Project. The duration of the assignment is expected to be for a period of thirty (30) days.

MOE now invites interested eligible individual consultants to submit Expressions of Interest for the provision of these consultancy services.

Consultants shall be eligible to participate if:

- (a) the persons are citizens or bona fide resident or residents of an eligible country; and
- (b) in all cases, the consultant has no arrangement and undertakes not to make any arrangements, whereby any substantial part of the net profits or other tangible benefits of the contract will accrue or be paid to a person not a citizen or bona fide resident of an eligible country.

Eligible countries are member countries of CDB.

In the assessment of submissions, consideration will be given to technical competence, qualifications and experience on similar assignments, and existing commitments. All information must be submitted in English. Further information may be obtained from the first address below between **0830 and 1600** hours Monday to Friday. Four hard copies of the Expressions of Interest must be received at the first address below no later than **1400 hours on Friday**, **October 28th**, **2016** and one (1) hard copy must be sent simultameously to CDB at the second address below. Following the assessment of submissions, the most technically capable and appropriately experienced applicant will be invited to negotiate a contract to provide the consultancy services. GOSVG reserves the right to accept or reject late applications or to cancel the present invitation partially or in its entirety. It will not be bound to assign any reason for not selecting any applicant and will not defray any costs incurred by any applicant in the preparation and submission of Expressions of Interest.
