#### (SECOND PUBLICATION)

**WHEREAS** it is enacted by Section 3 of the Land Acquisition Act Chapter 241 that if the Governor General considers that any land should be acquired for a public purpose, he may cause a declaration to that effect to be made:

**AND WHEREAS** it is considered by the Governor-General, that the under mentioned parcels of land should be acquired for a public purpose, to wit, Public Sector Development.

**NOW IT IS HEREBY DECLARED** by His Excellency, the Governor-General, acting in accordance with the advice of the Cabinet of Saint Vincent and the Grenadines, that upon the Second Publication of this Declaration in the Gazette, all that portion of land situated at Mt. Pleasant, in the Parish of St. George in the State of St. Vincent and the Grenadines belonging to Noel Baynes and et. al. measuring 600 and 3060 sq. ft. together with all ways water and watercourses rights, lights, liberties, privileges, paths, easements and all other appurtenances thereon shall vest absolutely in the Crown.
