NOW THEREFORE by virtue of the power of authority vested in me by the Saint Vincent Constitution Order 1979, and acting in accordance with the advice of the Honourable Prime Minister, I hereby charge you Honourable Montgomery Daniel, Minister of Housing, Informal Human Settlements, Lands and Surveys and Physical Planning with the due administration of the departments or subjects particularly enumerated hereunder according to the law and the usages of the Constitution from February 05, 2016 and until the resumption of duties by the HON. RALPH GONSALVES, Prime Minister, Minister of Finance, The Public Service, National Security, Legal and Grenadines Affairs.
