TO: SIR LOUIS STRAKER

WHEREAS by Instrument dated the 14th day of December, 2015, **HON. RALPH GONSALVES** was charged with the due administration of departments and subjects particularly enumerated herein according to the law and usages of the Constitution and subject to any variations which might thereafter be made to the said directions until the said directions as the same might be varied from time to time.

AND WHEREAS the said **RALPH GONSALVES** shall not be administering the departments or subjects with the administration of which he has been charged as aforesaid:

NOW THEREFORE by virtue of the power of authority vested in me by the Saint Vincent Constitution Order 1979, and acting in accordance with the advice of the Honourable Prime Minister, I hereby charge you Sir Louis Straker, Deputy Prime Minister and Minister of Foreign Affairs, Trade, Commerce and Regional Integration with the due administration of the departments or subjects particularly enumerated hereunder according to the law and the usages of the Constitution from March 1st, 2017 and until the resumption of duties by the **HON. RALPH GONSALVES**, Prime Minister, Minister of Finance, The Public Service, National Security, Legal Affairs and Grenadines Affairs.

POSTGRADUATE:

REQUIREMENTS FOR BACHELORS:

Applicants should not be older than Twenty-five (25) years and must have at least Five (5) GCE/CXC O'Levels (General Proficiency), including Mathematics, English Language and Biology, and at least Two (2) A'Level passes related to the proposed field of study.

Candidates are asked to note that the first (1st) year of instruction is dedicated to the Spanish language. Successful applicants will be required to work within the State of St. Vincent and the Grenadines upon completion of studies.

REQUIREMENTS FOR POSTGRADUATE:

Applicants for postgraduate studies must be graduates of the Latin American School of Medicine (ELAM), Cuba.

APPLICANTS MUST SUBMIT THE FOLLOWING:

- Birth Certificate
- Certified copies of educational qualifications
