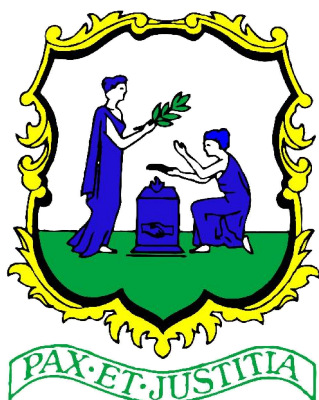

**INSTRUMENT OF RATIFICATION

AND THE OPEC FUND FOR
INTERNATIONAL DEVELOPMENT
(OFID)**

WHEREAS the OFID Agreement No. 12484PB for Agricultural Feeder Roads Project between Saint Vincent and the Grenadines (hereinafter called “the Borrower”) and the OPEC Fund for International Development (hereinafter called “OFID”) was signed on 23rd May, 2017;

AND WHEREAS it is provided in Article 3 that the said Agreement shall enter into force and effect in accordance with Section 3.02 following the receipt by OFID of the Instrument of Ratification and Legal Opinion in fulfillment of the effectiveness conditions stipulated in Section 3.01.

NOW THEREFORE, the Government of Saint Vincent and the Grenadines, having examined and considered the Agreement aforesaid, hereby confirms, and accepts and ratifies the same and undertakes faithfully to abide by the provisions therein contained.

IN WITNESS WHEREOF I, Dr. the Honourable Ralph E. Gonsalves, Prime Minister of Saint Vincent and the Grenadines, have signed this Instrument of Ratification and caused the official seal of Saint Vincent and the Grenadines to be affixed.
