The **St. Vincent and the Grenadines** has received financing from the Caribbean Development Bank (CDB) in an amount equivalent to **US\$12.317million** towards the cost of Technical and Vocational Educational Training Development Project and intends to apply a portion of the proceeds of this financing to eligible payments under a contract for which this invitation is issued. Payments by CDB will be made only at the request of the Government of St. Vincent and the Grenadines (GOSVG) and upon approval by CDB, and will be subject in all respects to the terms and conditions of the Financing Agreement. The Financing Agreement prohibits withdrawal from the financing account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of CDB, is

prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than GOSVG shall derive any rights from the Financing Agreement or have any claim to the proceeds of the Financing.

The Ministry of Education, National Reconciliation and Ecclesiastical Affairs (MOE), the Executing Agency, now wishes to procure consultancy services for **Development of a Life Skills Health and Family Life Education (HFLE)/Gender-Based Violence (GBV) Programme.**

The objective of the consultancy is to assist MOE with the design of a Life Skills/HFLE programme, including a focus on Gender Based Violence (GBV) to be implemented at the Technical Institutes, as part of the training. The duration of the assignment is expected to be for a period of four (4) months.

MOE now invites interested eligible individual consultants to submit Expressions of Interest for the provision of these consultancy services.

Consultants shall be eligible to participate if:

- (a) the persons are citizens or *bona fide* resident or residents of an eligible country; and
- (b) in all cases, the consultant has no arrangement and undertakes not to make any arrangements, whereby any substantial part of the net profits or other tangible benefits of the contract will accrue or be paid to a person not a citizen or *bona fide* resident of an eligible country.
