NOTICE

AGREEMENT

BETWEEN THE GOVERNMENT OF SAINT VINCENT AND THE GRENADINES AND THE GOVERNMENT OF THE RUSSIAN FEDERATION ON THE WAIVER OF VISA REQUIREMENTS FOR MUTUAL VISITS OF THE NATIONALS OF SAINT VINCENT AND THE GRENADINES AND OF THE NATIONALS OF THE RUSSIAN FEDERATION

The Government of Saint Vincent and the Grenadines and the Government of the Russian Federation, hereinafter referred to as "the Parties",

Desiring to further develop the friendly relations existing between the two States;

Seeking to facilitate the mutual travel procedures for the nationals of both States;

Have agreed as follows:

Article 1

- 1. The Nationals of Saint Vincent and the Grenadines holding valid ordinary, diplomatic and official passports (hereinafter referred to as "passports of Saint Vincent and the Grenadines"), and nationals of the Russian Federation holding valid passports giving the right to cross the border, including diplomatic and service passports (hereinafter referred to as "passports of the Russian Federation") may enter, leave, pass in transit and stay in the territory of the State of the other Party without obtaining a visa for not more than ninety (90) calendar days per each period of one hundred and eighty (180) days, starting from the date of the first entry.
- 2. Nationals of the State of one Party who intend to stay or reside in the territory of the State of the other Party for a period exceeding ninety (90) calendar days, or to take up employment or to engage in business activities in its territory shall obtain a visa at a diplomatic mission or consular post of that State in accordance with the legislation of the receiving State.

Article 2

- 1. Employees of diplomatic missions or consular posts of the State of one Party or missions to international organizations situated in the territory of the State of the other Party, holders of valid diplomatic, service or official passports as well as cohabitating members of their families, holders of valid diplomatic, service or official passports, may enter, leave, pass in transit and stay in the territory of the State of the other Party without obtaining a visa during the entire period of accreditation.
- 2. The Ministries of Foreign Affairs of both Parties shall inform each other beforehand about assignments of persons mentioned in paragraph 1 of this Article who must

be accredited before the Ministry of Foreign Affairs of the receiving State within the period of thirty (30) calendar days after their arrival.

Article 3

The Parties as soon as possible shall inform each other through diplomatic channels about any modifications of legislation and order of entry, stay and departure of the foreigners from the territories of their Staes.

Article 4

Nationals of the State of one Party referred to in Articles 1 and 2 of this Agreement may enter into the territory of the State of the other Party and leave its territory through the border-crossing points open to international passenger traffic.

Article 5

Nationals of the State of one Party, while in the territory of the State of the other Party, must comply with the laws and regulations of this State.

Article 6

The competent authorities of each Party may deny entry or shorten the period of stay of nationals of the other Party.

Article 7

- 1. Nationals of the State of one Party whose passports of Saint Vincent and the Grenadines or passports of the Russian Federation were expired, lost or damaged while in the territory of the State of the other Party may leave the territory of this State provided with valid passports of Saint Vincent and the Grenadiens or passports of the Russian Federation or temporary identification documents newly issued by their national diplomatic mission or consular post and giving the right to return to the State of their nationality, without obtaining any permission from the competent authorities of the receiving State.
- 2. Nationals of the State of one Party who are unable to exit from the territory of the

State of the other Party within the period specified in Article 1 of this Agreement due to documentarily or other credibly supported force majeure, shall request extension of a stay permit from the competent authorities for a period necessary to leave its territory in accordance with the legislation of the receiving State and without the need for a visa.

Article 8

- 1. For reasons of national security, protection of public order or public health or in order to prevent illegal immigration, either Party may suspend the application of this Agreement in whole or in part. The other Party shall be notified about the decision through diplomatic channels no later than seventy-two (72) hours prior to it becoming effective.
- 2. The Party which decided to suspend the application of this Agreement by the reasons specified in paragraph 1 of this Article shall immediately inform the other Party through diplomatic channels about the renewal of this Agreement once the reasons for suspension no longer exist.

Article 9

- 1. The Parties shall exchange specimens of passports through diplomatic channels not later than thirty (30) calendar days before the date this Agreement enters into force.
- 2. The Parties shall inform each other about the introduction of new passports of Saint Vincent and the Grenadines or passports of the Russian Federation or modifications to the existing ones, and shall transmit the specimens of new modified passports of Saint Vincent and the Grenadines or passports of the Russian Federation through diplomatic channels no later than thirty (30) calendar days before their introduction or modifications become effective.

Article 10

Any disputes between the Parties which may arise in the course of interpretation or application of this Agreement shall be resolved by them through diplomatic channels.

Article 11

This Agreement may be amended by the written consent of the Parties.

Article 12

This Agreement does not limit the rights and obligations of each Party arising from other international agreements to which its State is a party.

Article 13

This Agreement shall enter into force sixty (60) calendar days after the date of receipt through diplomatic channels of the latest written notification about completion by the Parties of their internal procedures necessary for its entry into force.

This Agreement is concluded for an indefinite period of time and shall cease to be in force ninety (90) calendar days after the date when one Party notifies the other Party in writing through diplomatic channels of its intention to terminate it.

Done at New York on 27th September, 2018, in two original copies, each in the English and Russian languages, both texts being equally authentic.
