ORGANISATION OF AMERICAN STATES (OAS) SCHOLARSHIP 2020

Applications are invited from suitably-qualified persons for scholarships offered by the Organisation of American States (OAS) for **undergraduate** and **postgraduate** studies for the 2020/2021 academic year. Applicants must be citizens or permanent residents of an OAS Member State.

UNDERGRADUATE

SCHOLARSHIPS are offered as a self-placed scholarship for the last two (2) academic years of study leading to an undergraduate degree. Applicants must be:

- enrolled in the programme of study and be eligible to graduate within two (2) academic years of study from the date of scholarship;
- accepted into the university where he/she
 plans to study for the last two (2)
 academic years of undergraduate degree
 (Bachelor's degree);
- be in good physical and mental health to complete programme.

Applicants already enrolled in a programme must submit current transcript and copies of CXC/GCE O' Level and A' Level Exam Certificate.

Applicants for **POSTGRADUATE STUDIES** must:

- have obtained a university degree (Bachelor's) at the time of submitting their applications;
- be enrolled in the programme of study and have at least one (1) academic year left from the date of scholarship offer, or

- be accepted into the university where he or she plans to study;
- submit a copy of degree certificate;
- be in good physical and mental health to complete programme.

Applicants who intend to pursue studies outside the Caribbean should sit the GRE or GMAT Exams. Also, note that the scholarship programme does not award scholarships for studies in the Medical Sciences or the learning of a new language.
