AND

IN THE MATTER OF THE ACQUISITION BY THE GOVERNOR-GENERAL

Of a certain parcel of land at Villa in the Parish of Saint George

DECLARATION OF ACQUISITION OF LAND

(Second Publication)

WHEREAS it is enacted by Section 3 of the Land Acquisition Act, Chapter 241 that if the Governor-General considers that any land should be acquired for a public purpose, she may cause a declaration to that effect to be made:

AND WHEREAS it is considered by the Governor-General, that the under-mentioned parcel of land should be acquired for a public purpose, to wit, for the Construction of Bathrooms and Washroom Facilities.

NOW IT IS HEREBY DECLARED by Her Excellency, the Governor-General, acting in accordance with the advice of the Cabinet of Saint Vincent and the Grenadines, that upon the Second Publication of this Declaration in the Gazette, all that portion of lands situated at Villa, in the Parish of Saint George in the State of Saint Vincent and the Grenadines belonging to Heirs of Hilda Punnett measuring in total 2,758 square feet together with all ways, water and watercourses, rights, lights, liberties, privileges, paths, easements and all other appurtenances thereon shall vest absolutely in the Crown.

AND IT IS HEREBY FURTHER DECLARED AND NOTIFIED that a copy of Survey Plan G 176 with a reserved area highlighted in blue outlining the above-mentioned area is at the Land and Surveys Department and can be inspected at all reasonable hours at the said Department.

REQUEST FOR EXPRESSIONS OF INTEREST

The Government of St. Vincent and the Grenadines (GOSVG) wishes to establish a Project Implementation and Management Unit (PIMU) within The Ministry of Transport, Works, Lands and Physical Planning (MTW). The PIMU will be responsible for implementing the three Caribbean Development Bank (CDB)-funded Natural Disaster Management Projects and the Sandy Bay Sea Defences Resilience Project assigned to MTW. As a result, the Ministry Wishes to procure consultancy services from eligible individuals for the position of **Project Engineer (PE)**.

The expected outcome of the Project is to contribute to increased resilience to natural disasters and Sandy Bay Projects, located along the north windward corridor of St. Vincent and the Grenadines.

The Project Engineer will be assigned exclusively to the Project and will report to the Project Manager (PM). The PE's duties will include, but not be limited to:

- (a) assisting the PM with the supervision of the engineering consultants, including review of the monthly reports prepared by the Engineering Consultants;
- (b) assisting the PM with the management and administration of the construction contracts;
- (c) preparation of the fortnightly progress spreadsheets within two days after the end of each fortnight for submission to PM;
- (d) any other duties assigned by the PM

Prospective candidates must be civil engineers with a minimum of the following qualifications:

- (a) A Masters Degree or equivalent in a civil engineering discipline, Project Management, Construction Management or related subject together with a minimum of five (5) years' experience in engineering design and supervision, including road works or project implementation; or
- (b) A Bachelors Degree in civil engineering and a minimum of eight (8) years of suitable experience in engineering design and supervision including road works or project implementation

The duration of the assignment is expected to be for a period of thirty six (36) months.

MTW now invites interested eligible individual consultants to submit Expressions of Interest for the provision of these consultancy services.

Consultants shall be eligible to participate if:

- (a) the persons are citizens or bona fide residents of an eligible country; and
- (b) in all cases, the consultant has no arrangement and undertakes not to make any arrangements, whereby any substantial part of the net profits or other tangible benefits of the contract will accrue or be paid to a person not a citizen or bona fide resident of an eligible country.

Eligible countries are member countries of CDB.

In the assessment of submissions, consideration will be given to technical competence, qualifications and experience, local and regional experience on similar assignments, financial capability and existing commitments. All information must be submitted in English. Further information may be obtained from the first address below between 0800 and 1600 hours Monday to Friday and the CDB website at www.caribank.org.

Incorporation and business activities

RBTT Bank Caribbean Limited ("the Company") was incorporated on February 5, 1985, under the laws of St. Vincent and the Grenadines. The Company offers a range of banking services to its customers through its operations in St. Vincent and the Grenadines, and its subsidiaries in Nevis (RBTT Bank (SKN) Limited) and Grenada (RBTT Bank Grenada Limited), together "the RBTT Group". The RBTT Group owns 96% of the issued share capital of RBTT Bank (SKN) Limited and 62% of the issued share capital of RBTT Bank Grenada Limited. The address of the Company's registered office and principal place of business is Halifax Street, Kingstown, St. Vincent and the Grenadines.

The Company is a wholly owned subsidiary of RBC Royal Bank Holdings (EC) Limited ("parent company"), a company which is also incorporated in St Vincent and the Grenadines, with the parent company being RBC Financial (Caribbean) Limited (formerly RBTT Financial Holdings Limited) which is incorporated in Trinidad and Tobago. On June 16, 2008 RBTT Financial Holdings Limited was amalgamated with RBC Holdings (Trinidad and Tobago) Limited to form the new entity RBC Financial (Caribbean) Limited. RBC Financial (Caribbean) Limited and its subsidiaries ("the Group") are engaged in the business of banking and the provision of financial services. Royal Bank of Canada ("RBC"), a Canadian chartered bank is the ultimate parent of the Group.

The RBTT Group is regulated by the Eastern Caribbean Central Bank (ECCB) and is licensed under the Banking Acts for the following countries:
