MEMORANDUM OF UNDERSTANDING BETWEEN THE AERONAUTICAL AUTHORITIES OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND SAINT VINCENT AND THE GRENADINES

INTRODUCTION

1. Delegations representing the Aeronautical Authorities of the United Kingdom of Great Britain and Northern Ireland ("UK") and the Aeronautical Authorities of Saint Vincent and the Grenadines met by video conference on the 27th September, 2021 to discuss an Air Services Agreement between their two countries.
2. Discussions were held in a friendly and constructive atmosphere. The composition of the two delegations is attached at **Annex A**.

NEW BILATERAL AIR SERVICES AGREEMENT

3. The delegations reached an understanding on, and initialled the text of, a new bilateral Air Services Agreement (the "ASA") between the UK and Saint Vincent and the Grenadines which is attached as **Annex B**.
4. The delegations decided that the ASA will be applied administratively from today's date, pending its signature and entry into force.
5. The delegations confirmed that they will endeavour to sign the ASA as soon as practicable after it begins to be applied administratively, to facilitate its entry into force in accordance with Article 25 (Entry into Force).

FREQUENCIES

6. The delegations decided that the designated airlines of each side are entitled to operate unlimited Third and Fourth Freedom air services in each direction, using any type of aircraft.

FIFTH FREEDOM TRAFFIC RIGHTS

7. It was jointly determined in accordance with Section 1 of the Route Schedule in the ASA, that the designated airline or airlines of the United Kingdom may exercise unlimited Fifth Freedom traffic rights between points in the territory of Saint Vincent and the Grenadines and any points in Central America, North America, South America, the Caribbean region or Europe to be nominated, and *vice versa*.

(a) The United Kingdom would like to initially nominate the following points:

- Antigua
- Barbados
- Dominican Republic
- Grenada
- Guyana
- Puerto Rico
- St. Kitts and Nevis
- St. Lucia
- Trinidad and Tobago

8. It was jointly determined in accordance with Section 2 of the Route Schedule in the ASA, that the designated airline or airlines of St. Vincent may exercise unlimited Fifth Freedom Traffic rights between points in the territory of the United Kingdom and any

points in Central America, North America, South America, the Caribbean region or Europe to be nominated, and vice versa.

(a) Saint Vincent and the Grenadines would like to initially nominate the following points:

- Antigua
- Barbados
- Dominican Republic
- Grenada
- Guyana
- Puerto Rico
- St. Kitts and Nevis
- St. Lucia
- Trinidad and Tobago

SEVENTH FREEDOM ALL -CARGO TRAFFIC RIGHTS

9. The delegations decided that there will be no restrictions on the number of all-cargo services operated on a Seventh Freedom basis by the designated airlines of either side.

CHARTER SERVICES

10. Both delegations affirmed the intention of their respective Aeronautical Authorities, within the scope of Article 5 of the Chicago Convention, to adopt a flexible policy, to charter services between the two countries and their willingness in principle to approve applications for such flights, subject to the understanding that reciprocal treatment will be granted by the other Aeronautical Authority.
11. The Aeronautical Authorities of both sides will use their best endeavours to decide on charter flight applications with the shortest possible time.
12. For the avoidance of doubt, both delegations decided that the provisions relating to security and safety contained in the ASA shall, as soon as it comes into effect, also be applicable to the operation of charter services.

ENTRY INTO OPERATION

13. This Memorandum of Understanding enters into effect on the date of the later Signature below.
