MOTION

2023 Estimates of St. Vincent and the Grenadines

Moved by the Honourable Minister of Finance:

WHEREAS section 70(1) of the Constitution of Saint Vincent and the Grenadines provides that the Minister for the time being responsible for finance shall cause to be prepared and laid before the House of Assembly before, or not later than thirty days after, the commencement of each financial year Estimates of the Revenues and Expenditure of Saint Vincent and the Grenadines for that financial year;

AND WHEREAS section 70 (2) of the Constitution provides for the approval of the Estimates of expenditure by the House;

AND WHEREAS the Government had additionally decided to prepare estimates on a triennial basis:

BE IT RESOLVED that this Honourable House of Assembly do adopt the Estimates for the financial year ending 31st December, 2023;

AND BE IT FURTHER RESOLVED that this Honourable House note the projections for the financial years ending 31st December, 2024 and 31st December, 2025.

RESOLUTIONS

Moved by the Honourable Minister of Finance:

BE IT RESOLVED that this Honourable House do authorise the Minister of Finance to borrow by means of fluctuating overdraft or otherwise from First Caribbean Bank or the Republic Bank Ltd., or the Bank of Saint Vincent and the Grenadines Ltd., money to an amount not exceeding in the aggregate fifty million dollars, during the period 1st January, 2023 to 31st December, 2023 for the purpose of meeting the liquidity requirements of the Government.

VALUE ADDED TAX (AMENDMENT) REGULATIONS 2022

Moved by the Honourable Minister of Finance:

WHEREAS under section 58 of the Value Added Tax Act, Chapter 445, the Minister may make regulations for any matter that in the Act requires or allows to be prescribed by regulations or for any matter that is necessary or convenient to be prescribed in order to better carry out or give effect to the purpose of the Act;

AND WHEREAS under section 58 (3) of the Act regulations made under the Act are subject to an affirmative resolution of the House of Assembly;

NOW THEREFORE BE IT RESOLVED that the House of Assembly approve the draft Value Added Tax (Amendment) Regulations 2022.
