The St. Vincent and the Grenadines Financial Services Authority hereby gives notice of decision to cancel the Calliaqua Provident Friendly Society registration pursuant to Section 74 (2) of the Friendly Societies Act No. 8 of 2021 ("the Act").

Pursuant to Section 74 (1) of the Act, a notice of the intended cancellation was issued to the **Calliaqua Provident Friendly Society** on January 26th, 2023, outlining the following grounds:

- Inactivity relating to the core business of the friendly society since 2019
- Deterioration in the quality of oversight management and accountability
- Unavailability of crucial financial records and membership information
- The reduction in the membership below the minimum requirement
- Non-Payment of annual fees for the years 2017-2022

Consequently, pursuant to Section 74(3) of the Act, the cancellation of the Calliaqua Provident Friendly Society is effective June 21st, 2023.
