NOTICE TO LEGAL PRACTITIONERS

TAKE NOTICE THAT the E-Litigation Portal (the “Portal”) is scheduled to go live for Saint Vincent and the Grenadines on **Wednesday, 17th May, 2023** for the mandatory electronic filing of all new civil proceedings, including family matters, filed in the Magistrate’s Court in the state.

Once the Portal goes live from **Wednesday, 17th May, 2023**, no manual filings will be accepted by the Magistrates Court Office for any of the proceedings which are initiated on the Portal. All new civil proceedings in the Magistrate’s Court must be filed on the Portal after the go live.

All legal practitioners who have not already done so, are therefore required register themselves and their law Firms on the Portal, create an account on the Portal and make a payment to place funds into their firms’ escrow account in order to avoid any inconvenience when filing. The above is required to utilise the platform in accordance with the Rules when filing documents in matters available on the Portal. Legal practitioners are also advised that filing fees in the Magistrate’s Court will no longer be accepted in the form of stamps. Such fees must be paid at the Magistrate’s Court office by cash or cheque.

We would appreciate if Legal Practitioners whose law firms only file in the Magistrates Courts and have never registered or filed documents on the Portal can advise the Registrar of the High Court by **Tuesday 2nd May 2023**, so that a special informational session can be arranged with you and or a representative of your law firm.


