REQUIREMENTS FOR BACHELORS

Applicants should not be older than twenty-five (25) years and must have at least five (5) GCE/CXC O' Levels (General Proficiency), including Mathematics, English Language and Biology, and at least two (2) A' Level Passes related to the Proposed field of study.

Candidates are asked to note that the first (1st) year of instruction is dedicated to the Spanish language. Successful applicants will be

required to work within the State of St. Vincent and the Grenadines upon completion of studies.

REQUIREMENTS FOR POSTGRADUATE

Applicants for postgradute studies must be graduates of the Latin American School of Medicine (ELAM), Cuba.

- Birth Certificate
- Certified copies of educational qualifications
