Candidates are asked to note that the first (1st) year of instruction is dedicated to the Spanish language. Successful applicants will be

required to work within the State of St. Vincent and the Grenadines upon completion of studies.

#### REQUIREMENTS FOR POSTGRADUATE

Applicants for postgradute studies must be graduates of the Latin American School of Medicine (ELAM), Cuba.
