MOTIONS AND RESOLUTION

2025 ESTIMATES OF
SAINT VINCENT AND THE
GRENADINES

The Honourable Minister of Finance moved the following motion:

WHEREAS section 70(1) of the Constitution of Saint Vincent and the Grenadines provides that the Minister for the time being responsible for finance shall cause to be prepared and laid before the House of Assembly before, or not later than thirty days after, the commencement of each financial year Estimates of the Revenues and Expenditure of Saint Vincent and the Grenadines for that financial year;

AND WHEREAS section 70(2) of the Constitution provides for the approval of the Estimates of Expenditure by the House;

AND WHEREAS the Government had additionally decided to prepare Estimates on a triennial basis:

BE IT RESOLVED that this Honourable House of Assembly do adopt the Estimates for the financial year ending 31st December, 2025;

AND BE IT FURTHER RESOLVED that this Honourable House note the projections for the financial years ending 31st December, 2026 and 31st December, 2027.

The Resolution 2025 was approved on Friday 17th January, 2025.

Resolution

The Honourable Minister of Finance moved the following resolution:

BE IT RESOLVED that this Honourable House do authorise the Minister of Finance to borrow by means of fluctuating overdraft or otherwise from 1st National Bank St. Lucia Limited, or the Republic Bank Limited or the Bank of St. Vincent and the Grenadines, money to an amount not exceeding in the aggregate eighty-five million dollars, during the period 1st January, 2025 to 31st December, 2025 for the purpose of meeting the current requirements of the Government.
