NOTICE OF NOMINATION

Her Excellency the Governor-General having issued the writs for the Election of Members of the House of Assembly for all the Constituencies of the State, the Returning Officers of the said Constituencies will, on the 10th day of November, 2025 between the hours of 9:00 a.m. and 12:00 noon at the places hereinafter mentioned, proceed to the nomination and if there is no opposition, to the election of members for the said Constituencies.

Forms of nomination papers may be obtained from the Returning Officers between the hours of 9:00 a.m. and 12:00 noon on the 10th day of November, 2025 at the places hereinafter mentioned.

Every nomination paper must be signed by any six or more electors qualified to vote in the Constituency of which the Candidate is seeking election, and be handed to the Returning Officer between the said hours of 9:00 a.m. and 12:00 noon.

No nomination paper shall be valid or acted upon by the Returning Officer unless it is accompanied by-

- (a) the consent in writing of the person therein nominated;
- (b) deposit of five hundred dollars in cash; and
- (c) the required statutory declaration in Form 3 as set out in the Appendix to the House of Assembly Election Rules.

In the event of the election being contested, the Poll will take place between the hours of 7:00 a.m. and 5:00 p.m. on the 27th day of November, 2025.

Directions for the Guidance of Voters in Voting

- 1. Each voter may vote only at one polling station.
- 2. The voter should see that the ballot paper before it is handed to him is stamped with the official mark and bears the initials of the presiding officer.
- 3. The voter shall go into one of the compartment and with the black lead pencil provided in the compartment and place one cross, thus X in the blank space on the right hand side of the ballot paper opposite the response the voter wishes to give to the question on the ballot paper.
- 4. The voter shall then fold the ballot paper so that the initials of the presiding officer the official mark and the numbers on the counterfoil can be seen and the counterfoil detached without opening the ballot paper, he shall then return the ballot paper so folded to the presiding officer, who shall in full view of those present, including the voter, remove the counterfoil, and place the ballot paper in the ballot box. The voter shall then forthwith quit the polling station.
- 5. If a voter inadvertently spoils a ballot paper he may return it to the presiding officer who on being satisfied of the fact will give him another.
- 6. If the voter places on the ballot paper any mark in both the said spaces, or places any mark on the paper by which he may afterwards be identified his vote will be void and will not be counted.
- 7. If the voter fraudulently takes a ballot paper out of a polling station or fraudulently puts into the ballot box any paper, other than the one given to him by the officer, he will be liable to imprisonment for six months.
