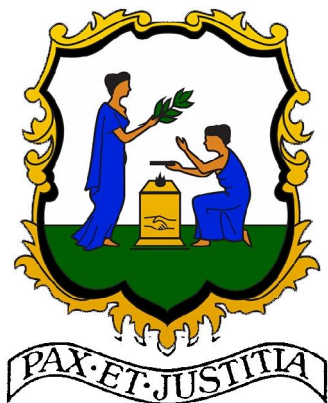

I hereby charge you Honourable St. Claire Leacock, Deputy Prime Minister and Minister of National Security, Disaster Management and Immigration with the due administration of the departments or subjects particularly enumerated hereunder according to the law and usages of the Constitution from 5th July, 2026, and until the resumption of duties by the HONOURABLE GODWIN FRIDAY, Prime Minister, Minister of Finance, Legal Affairs and Justice, Economic Planning and Private Sector Development.
